Failure to pay for said changes(s), as agreed herein, shall be deemed by the Vendor as the Purchaser's rescinding of said change(s) requested and the Vendor shall be at liberty to complete the Unit to its original specifications.

b. in addition to all other reasonable costs, additional charge(s) may be made for professional fees incurred by the Vendor from its architects, engineers, etc., for the purpose of incorporating the Purchaser's change(s); and

c. any credits requested by the Purchaser as a result of items(s) to be deleted, shall be based on credit(s) issued to the Vendor by the subcontractors/trades responsible for the item(s) so deleted, and in this regard the Purchaser acknowledges that credits(s) are calculated on control prices for the entire project, and may be substantially less than retail prices normally charged for such item(s).

d. unexecuted requests by the Purchaser as follows:

- b. The Vendor agrees to supply and install engineered hardwood flooring as per the "hallway, bedrooms, and Den" additional costs including areas such as the living room, dining room, hallway, bedrooms, and Den (if applicable) as per floor plan.
