General Power of Attorney

On this Tuesday, Feb. 01, 2011:

Attended before me, I the attorney, Ezzeddin Hasan Khawaja, of the Ali Habib and Associates Law Firm, licensed to practice law under # 7477 Ministry of Justice in Abu Dhabi, UAE, Mr. **Solak Atanos Bedros**, of the Iraqi nationality, and upon acknowledging his identity as per his passport # 0313705 and in my presence and his attendance, he willingly declared before me that he is authorizing his brother, **Varant Petros**, a Canadian citizen, holding passport # BA487066, to act on his behalf to sell and purchase and receive and spend and deal with the banks to open all kind of banking accounts and request for guarantees and sign cheques, and that this authorization covers and includes the right of proceeding with full power and sign all types of banking accounts without any exception, whether accounts were opened prior to or after the date of this authorization, and whether those accounts were opened by me or by the person who is authorized, and whether opened under my personal or the entity's name in other words, under the name of the companies affiliated or owned by me, and whether sole proprietor or partnership with the others or by way of authorization where his presence or signature represent my presence personally or my signature and whether these companies exist or to be established in the future and whether explicitly mentioned or not, also this authorization includes purchasing real estates, including lands, houses, residential condominiums and other types, no matter.

This power of attorney is addressed to all governmental departments, whether the local ones or Ministries in Canada and to whom it may concern, whether clearly mentioned or mentioned within or not mentioned, and to represent the authorizer as a claimant or respondent at all degrees of courts, and to appeal, reject, execute, request for precautionary (provisional) seizure an implementation and to remove it, and to represent the authorizer before all official departments, and that the authorized person has the right to do whatever suitable in the authorizer's interest, and to give him the right to act legally and lawfully on behalf of the authorizer, also the authorized person has the right to empower a third party of all or part of what he has been authorized to act upon, as well as the right to act on my behalf to sign, sell, purchase lands, enterprises, vehicles, stores, real estates, equities, a general power of attorney includes the right of sell and lands mortgaging.

A general and absolute power of attorney issued in favour of the authorized person and upon reciting it before the authorizer, he declared the authenticity of the content and signed it before me requesting to be certified. I have duly signed and sealed it.
