 - 2.3. in addition to all other reasonable costs, additional charges(s) may be made for professional fees incurred by the Vendor in its architecture, engineers, etc., for the purpose of incorporating the Purchaser's changes(s); and
 - 2.4. any credit(s) issued to the Purchaser as a result of item(s) to be deleted, shall be based on credit(s) issued to the Vendor by the subcontractor(s) responsible for the item(s) so deleted, and in this regard the Purchaser acknowledges that such credit(s) are debased on contract prices for the entire project and may be substantially less than retail prices normally charged for such item(s).

3. The change(s) requested by the Purchaser are as follows:

1. To add a walk-in pantry and install Stainless Steel Kitchen Appliances consisting of Fridge,
