

POWER OF ATTORNEY FOR PROPERTY
(General Power of Attorney made in accordance with the
Powers of Attorney Act and the *Substitute Decisions Act*, 1992)

1. I, **Xiangjun YAN**, hereby appoint **Seung Tung Eric NG**, to be my attorney for property.

2. I revoke any previous continuing power of attorney for property made by me.

3. I AUTHORIZE my attorney for property to do on my behalf, anything that I can lawfully do by an attorney, and specifically anything in respect of property that I could do if capable of managing property, except make a Will, subject to the law and to conditions or restrictions contained in this document.

4. In accordance with the *Substitute Decisions Act*, 1992, I declare that this Continuing Power of Attorney may be exercised during my subsequent legal incapacity on my part. This document shall be a Continuing Power of Attorney for Property under the *Substitute Decisions Act*, 1992, and may be used during my incapacity to manage property.

5. In accordance with the *Substitute Decisions Act*, 1992, I declare that, after due consideration, I am satisfied that the authority conferred on the attorney for property named in this Continuing Power of Attorney for Property is adequate to provide for the effective management of all my estate in case I should become a patient in a psychiatric facility and be certified as not competent to manage my estate. I direct that, in that event, my attorney for property shall retain this Continuing Power of Attorney for Property for the management of my estate and it is my wish that the Public Guardian and Trustee shall not continue as the statutory guardian of my estate.

6. **FAMILY LAW ACT CONSENT**

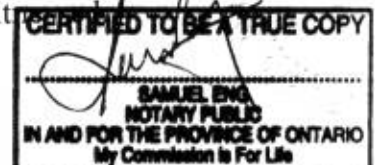


