INSERT TO THE AGREEMENT OF PURCHASE AND SALE

Upgrade Allowance in lieu of Custom Designed Closets in Master Bedroom

- (a) Provided that the Purchaser is not in default at any time under this Agreement, the Vendor agrees to credit the Purchaser with an Upgrade Allowance to a maximum of One Thousand dollars (\$1,000.00) towards upgrades selected at colour selection time. The Purchaser(s) may only purchase upgrades from the Vendors exclusive selection at colour satisfaction. No cash or credit will be provided for any unused balance remaining from the \$1,000.00 maximum upgrade allowance.

- (b) This Upgrade Allowance is personal to the Purchaser, is not transferable or assignable and shall automatically terminate without notice or any further process if this Agreement for any interest therein or title to the Property is transferred or assigned by the Purchaser (even though the Vendor may have consented to such transfer or assignment).

- (c) Without limiting anything contained herein, (i) the provisions of the Upgrade Allowance shall automatically terminate without notice or any further process if the Purchaser defaults in any of the Disobligations of the Agreement and notwithstanding that such default is cured or rectified; and (ii) the Vendors obligation to provide the Upgrade Allowance is conditioned upon the Purchaser clearing the termination contemplated by this Agreement.
