

The said CCP and PDI Forms that he executed by both the Purchaser and the Vendor's representative at the PDI and shall constitute the Vendor's only undertaking with respect to incomplete or deficient work. Except as to those items specifically fisted on the PDI or CCP forms, the Purchaser shall be deemed to have acknowledged that the Unit has been completed in accordance with the provisions of the Agreement and the Purchaser shall be deemed conclusively to have accepted the Unit. In the event that the Vendor performs any additional work to the Unit in its discretion, the Vendor's shall not be deemed to have wrived the provision of this paragraph or otherwise enlarged its obligations bereunder. The completion of the PDI and acceptancy to the Unit to the Purchaser are conditions of the Vendor's obligation to provide nocupancy to the Unit to the Purchaser shall not be entitled to enter the Unit or the Property prior to the Occupancy Date.

The Purchaser agrees that the foregoing may be pleaded by the Vendor as an estoppel in any action brought by the Purchaser or his successors in title against the Vendor. The Vendor may, from time to time, change, vary or modify in its sole discretion or at the instance of any governmental authority or mortgage, any standards, building specifications or site plans of any part of the Unit and the Condominium, to combine with any municipal or architectural requirements related to building codes, official plan or official plan amendments, againg by-laws, committee of adjustment and/or land division committee decisions, municipal site plan approval or architectural control. Such changes may be to the plans and specifications existing at integrition of the Condominium or as they existed at the time the Purchaser entered into this Agreement, or as illustrated on any sales material, including without limitation brochures, models or otherwise. With respect to any aspect of construction, finishing or equipment, the Vendor shall have the right, without the Purchaser's consent, to substitute materials for those described in this Agreement or in the plans or specifications, provided the substituted materials are, in the judgment of the Vendor, whose determination shall be final and binding, of equal or better quality. The Purchaser shall have no claim against the Vendor for any such changes, variances or modifications oor shall the Vendor he required to give notice thereof.
