- Ņ the Purchase Agreement The Additional Unit Purchase Price shall be in addition to the purchase price of the Residential Unit as same is set out in
- ယ A Deposit of Two Thousand (\$2000.00) Dollars of the Additional Unit Purchase Price is payable upon execution hereof, by cheque made payable to the Vendor's solicitors, Aird & Berlis LLP, in trust, which deposit will be credited to the Purchaser on the Statement of Adjustments on the Closing Date, and the balance of the Additional Unit Purchase Price is to be paid by the Purchaser to the Vendor's solicitors, Aird & Berlis LLP, in trust, by certified cheque on the Closing Date.
- 4. The Purchaser expressly agrees that any adjustments to the common expenses payable with respect to the purchase of the Additional Unit and in particular any additional or increased common expenses owed by the Purchaser therefor, will be reflected on the Statement of Adjustments.
- Ġ The Purchaser acknowledges that the Additional Unit is subject to monthly common expenses which are set out in Schedule D to the proposed Declaration as well as in the Schedule of Monthly Common Expenses included with the Budget in the Disclosure Statement and that the Purchaser has reviewed and accepts same.
