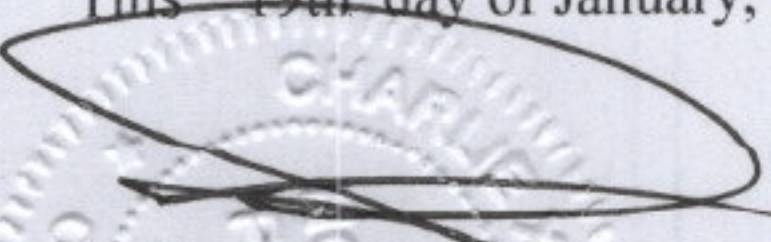

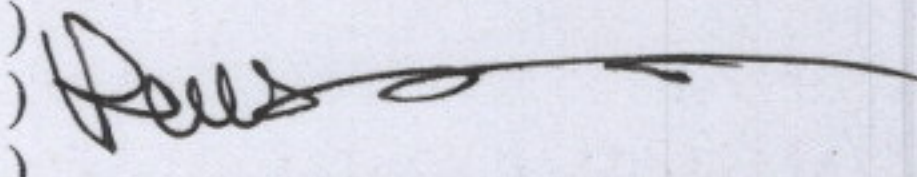
1. I am one and the same person as Ruben Jun ZHANG, born April 2, 1970;
