IN THE EVENT OF LIQUIDATION, DISSOLUTION OR WINDING UP OF THE CORPORATION, THE HOLDER OF EACH COMMON SHARE SHALL BE ENTITLED TO THE PROPERTY OF THE CORPORATION IN ACCORDANCE WITH THE RIGHTS, PRIVILEGES AND CONDITIONS AS DETERMINED BY THE DIRECTORS FOR EACH SERIES OF SHARES.
