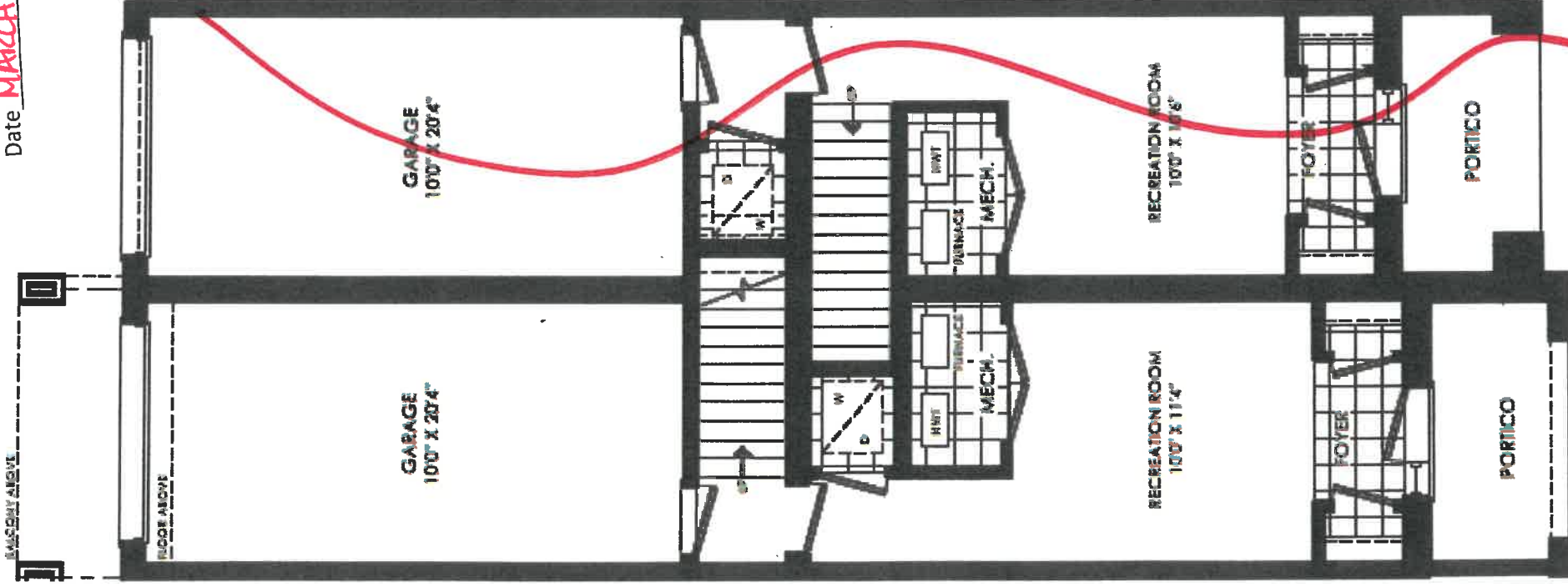

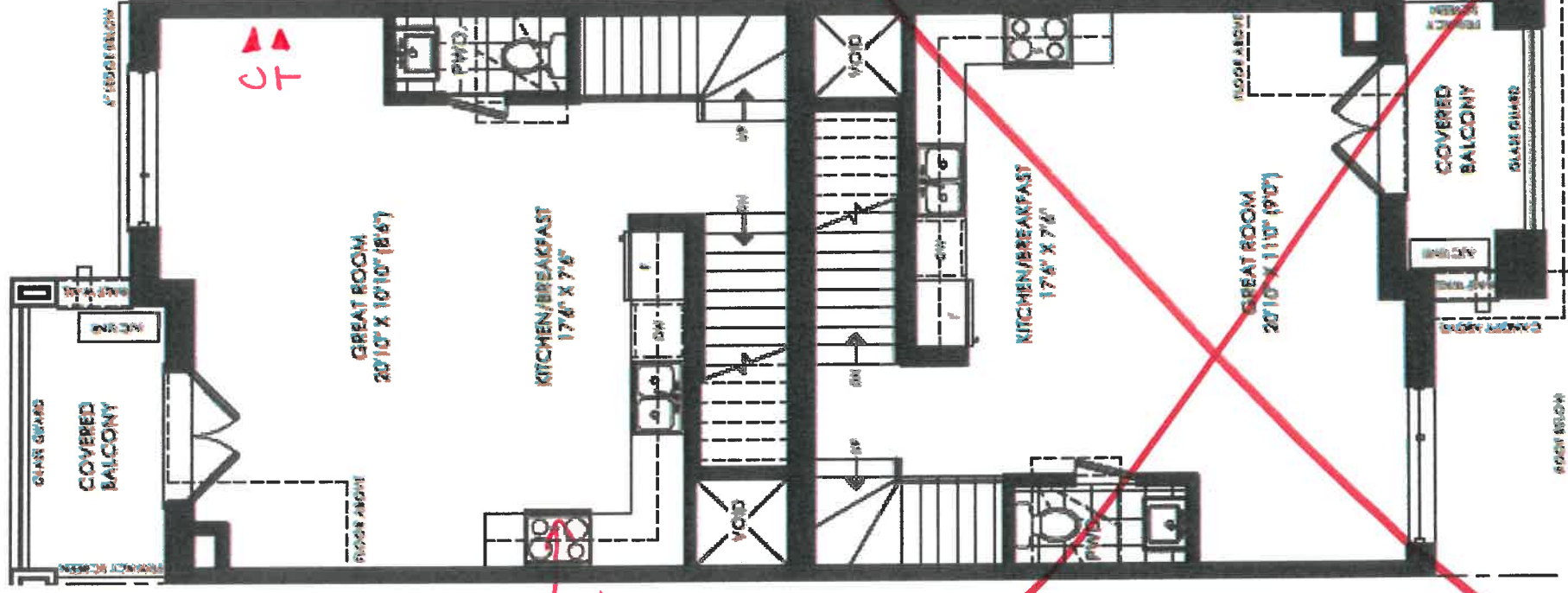


TH-1 ELEV 1

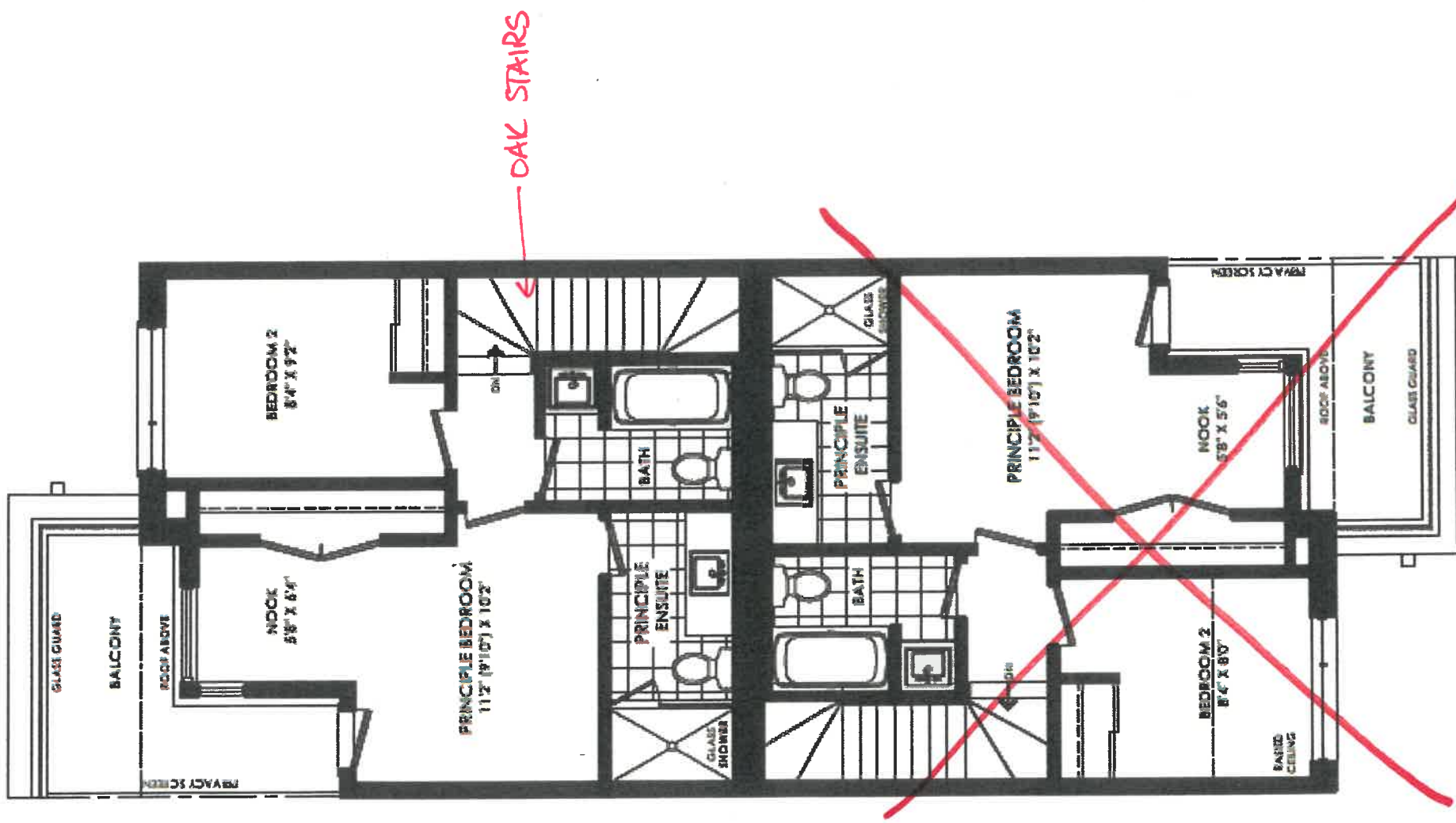
