For any work orders issued for which there is no contract price subcontractor is to obtain a purchase order from Head Office.

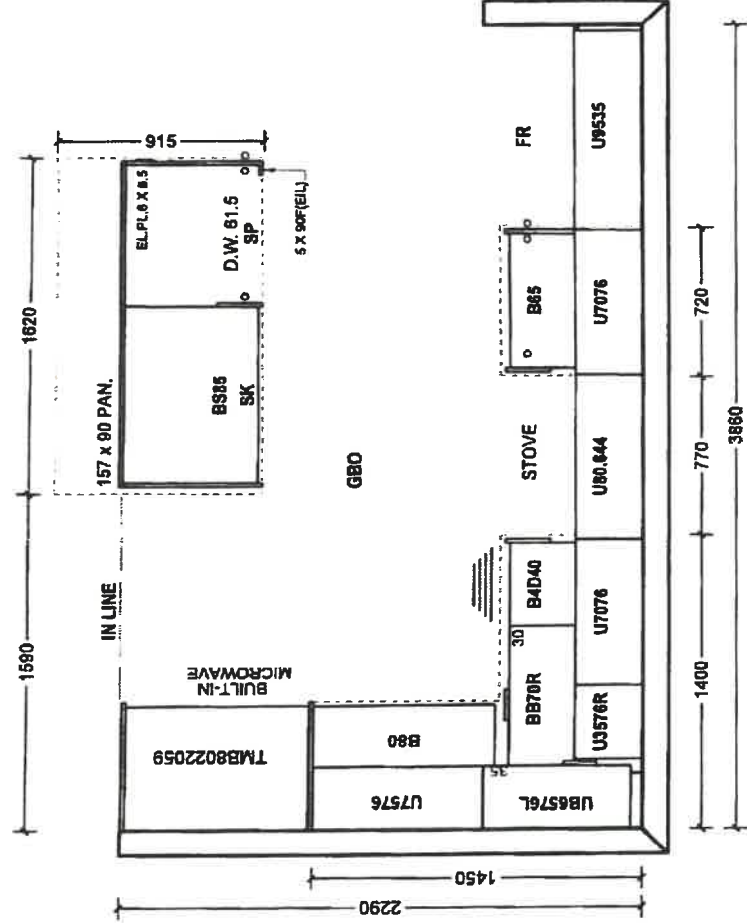

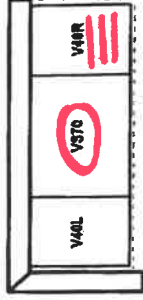
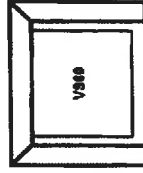
