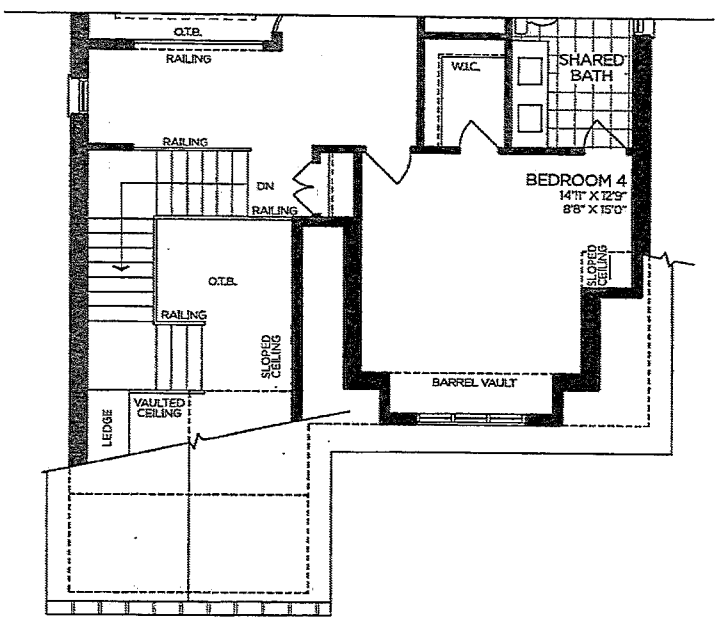
PART. OPT. GROUND FLOOR | ELEV. A
