

4) The Purchaser agrees that this colour selection is final and that no changes will be permitted, unless required by the Vendor.

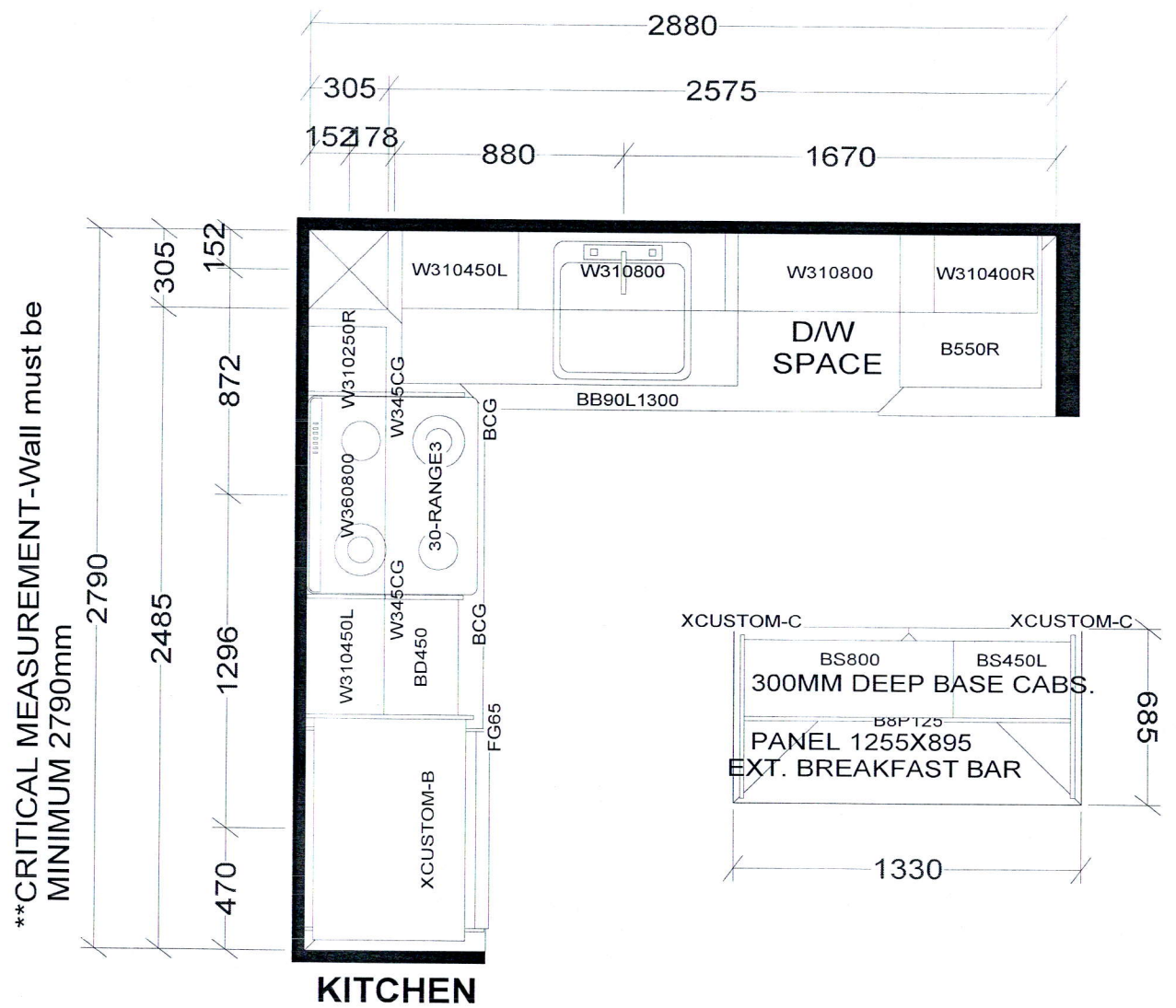
