Natural Stone

Marble is not recommended in high traffic areas, such as the kitchen, as marble is a more porous stone

Ceramic Tile

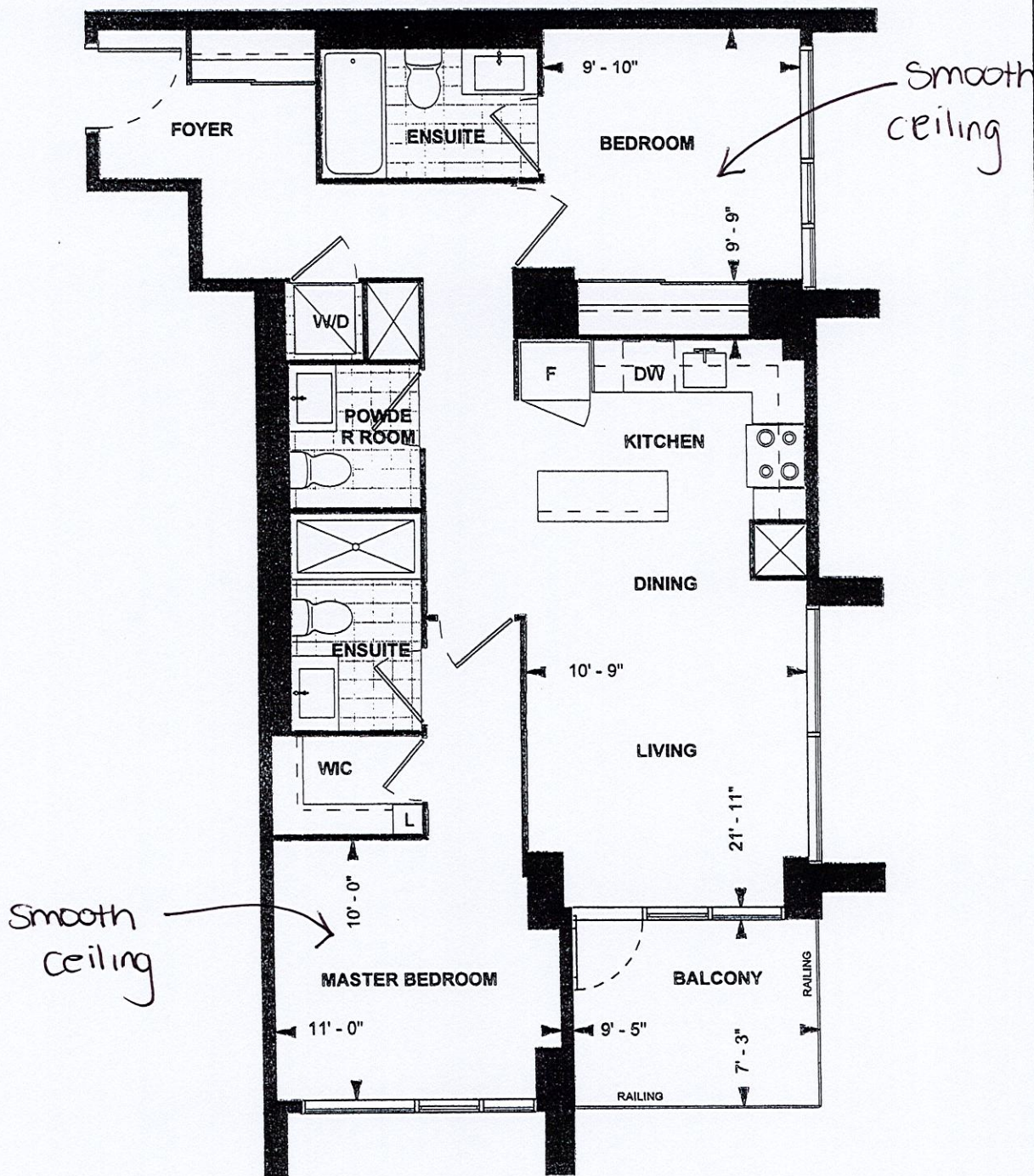

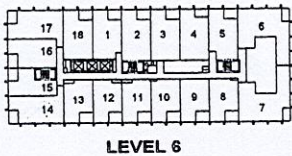
