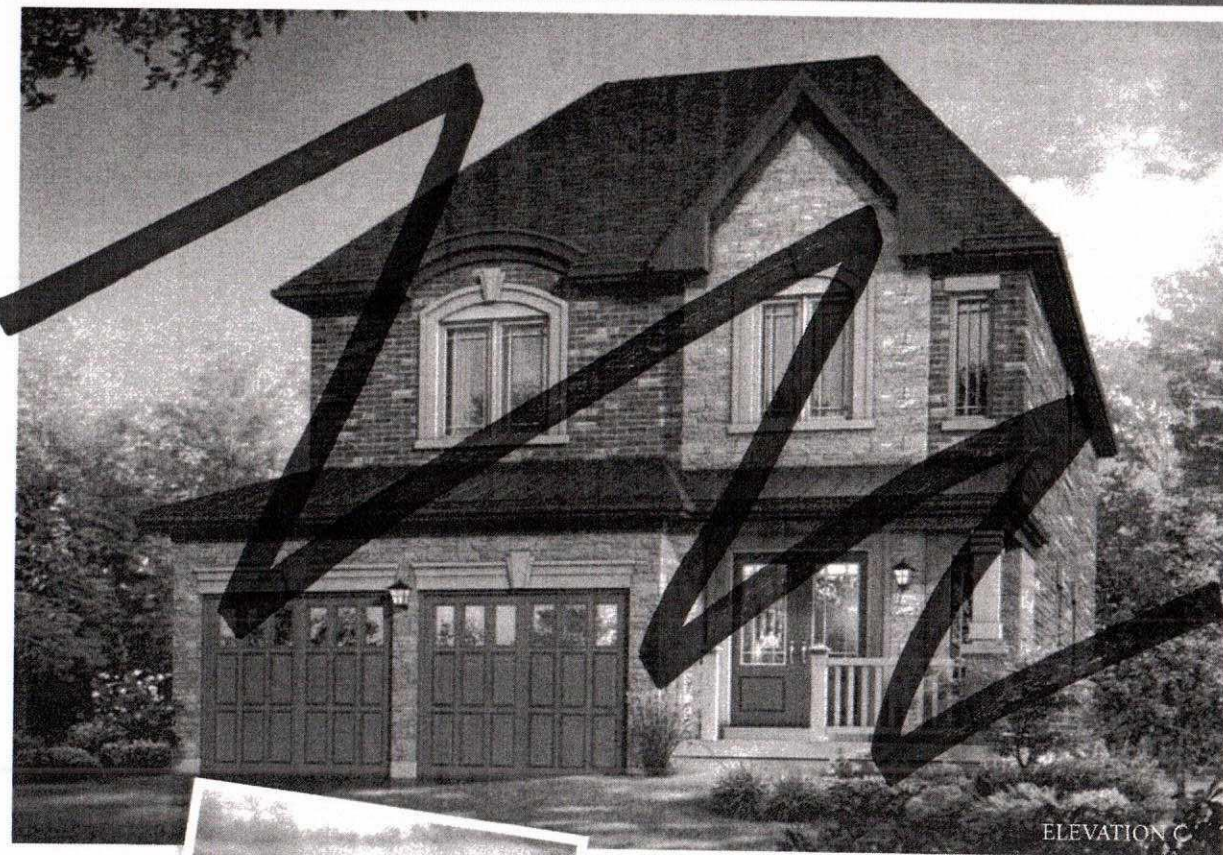

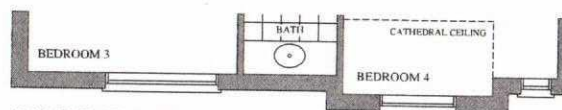
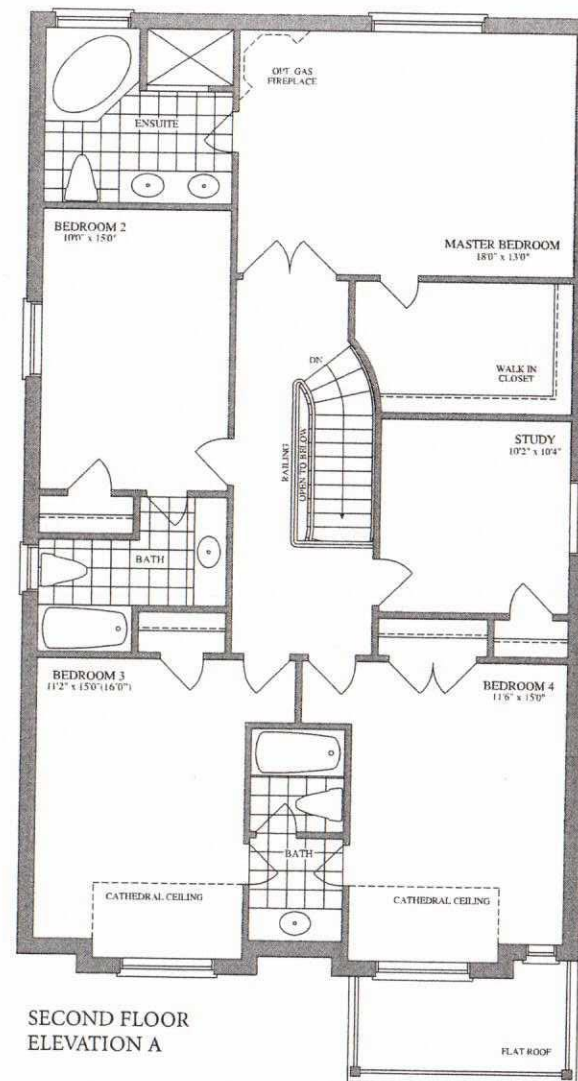


FIRST FLOOR  
ELEVATION A, C

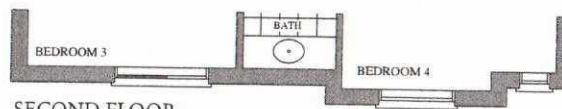

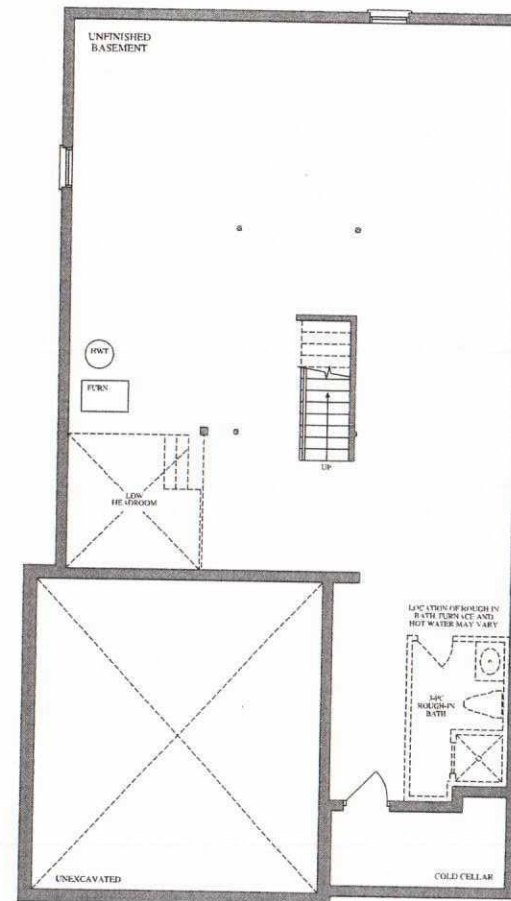
