



AMENDMENT TO AGREEMENT OF PURCHASE AND SALE
(the "Amending Agreement")

BETWEEN: Queenswell Ltd. (the "Vendor") and

WHEREAS:

- A. It is hereby understood and agreed between the Vendor and the Purchaser that the following change(s) shall be made to the Purchase Agreement, and except for such change(s) noted below in this Section 1, all other terms and conditions of the Purchase Agreement shall remain as stated therein, and time shall continue to be of the essence.


