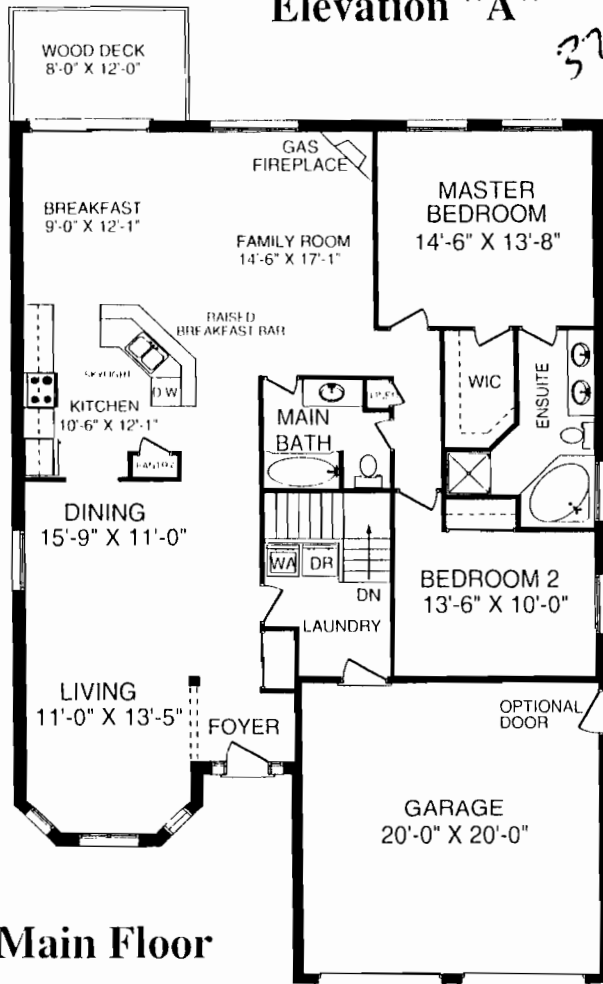

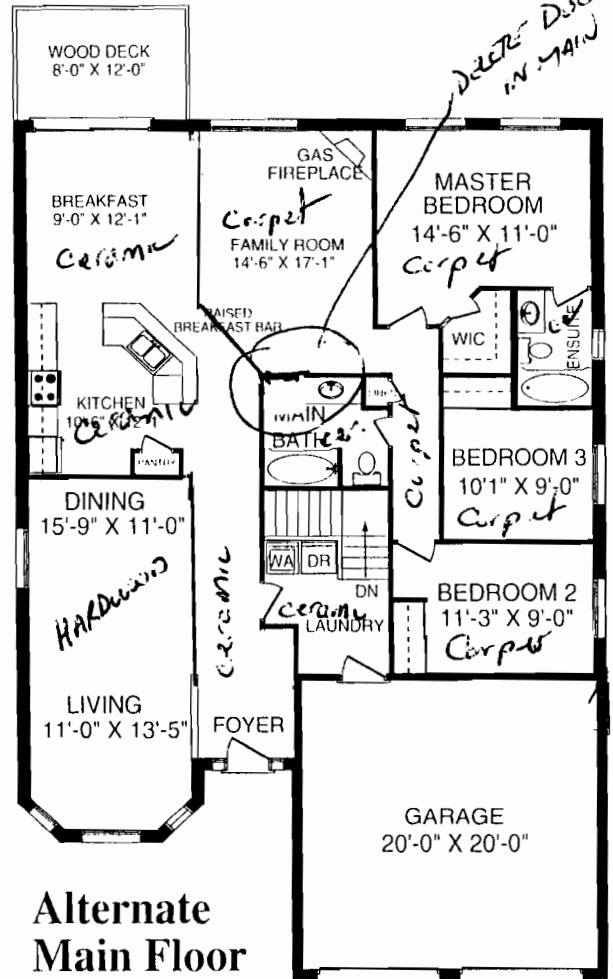

**Elevation "A"**

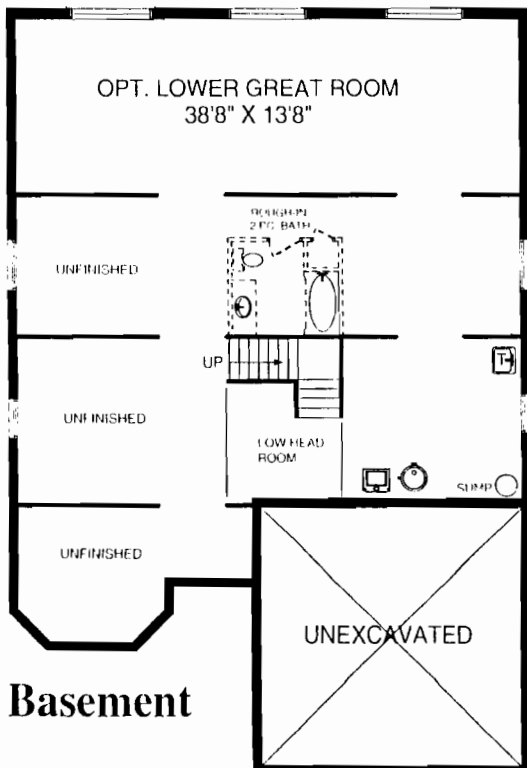

**Main Floor**



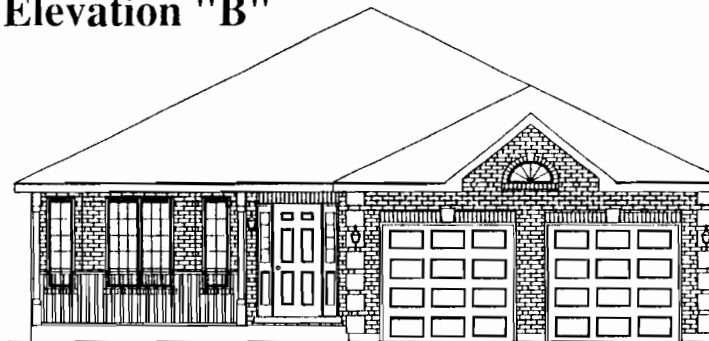
**Alternate
