HARDWOOD CRACKED FIECE IN FRON OF BASEMENT STAIRS WHERE MARKED. 2 HOLES IN DIFFERENT PIECES OF HARDWOOD WHERE MARKEED, NAIL STICKING OUT OF BOARD TO LEFT OF PLOORING WINDOW WHERE MARKED.

WALLS CETLING SCRAPED TO LEFT OF LIGHT FIXTURE

KITCHEN WALLS PAINT JOB ON CEILING VERY SPOTTY. TRIM CUTS IN WALKTRHOUGH WALL TO LIVING ROOM ON TRIM
