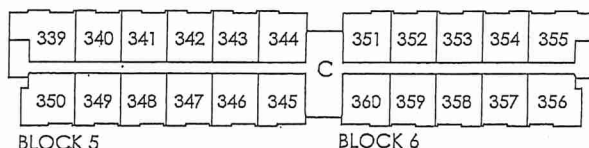
Tile Direction
