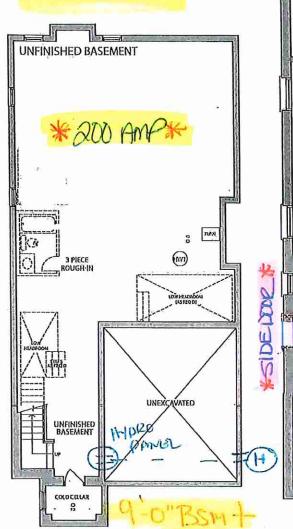

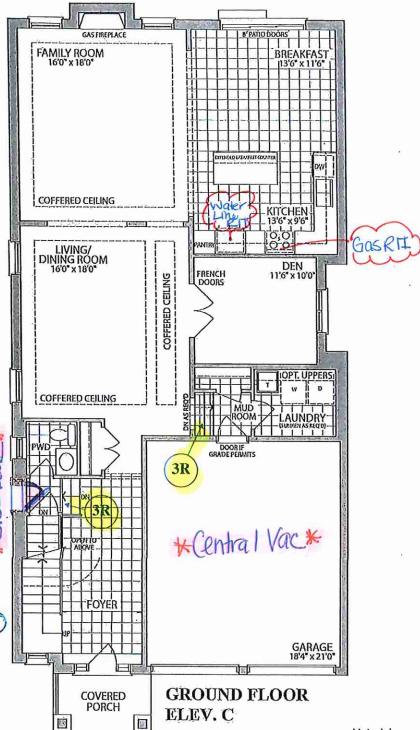

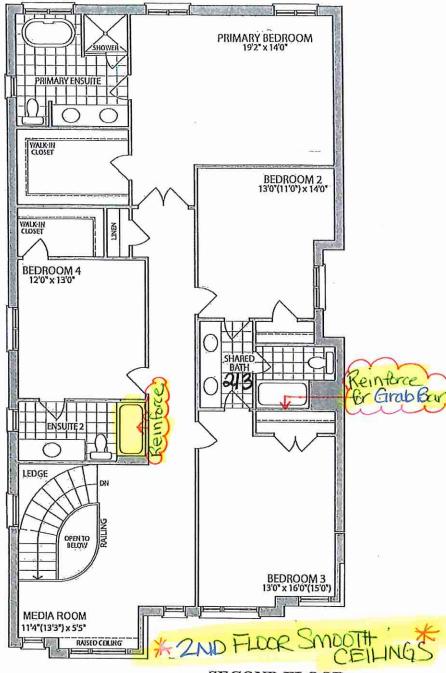






BASEMENT ELEV. C
