Hi,

This appears to be a full foundation on the side wall, with about 5' 1" of exposure above grade at the rear. The floor joists are running front to back, not side to side so it might be tight trying to get up into the header. It may require a foundation core to get out below the header and still be a minimum 12" above grade with our cap in that location. The price will be as per the optional basement location if it can get in through the header. The price difference is minimal between the two locations, \$123. We do not core foundations. We should have a look at it first.
