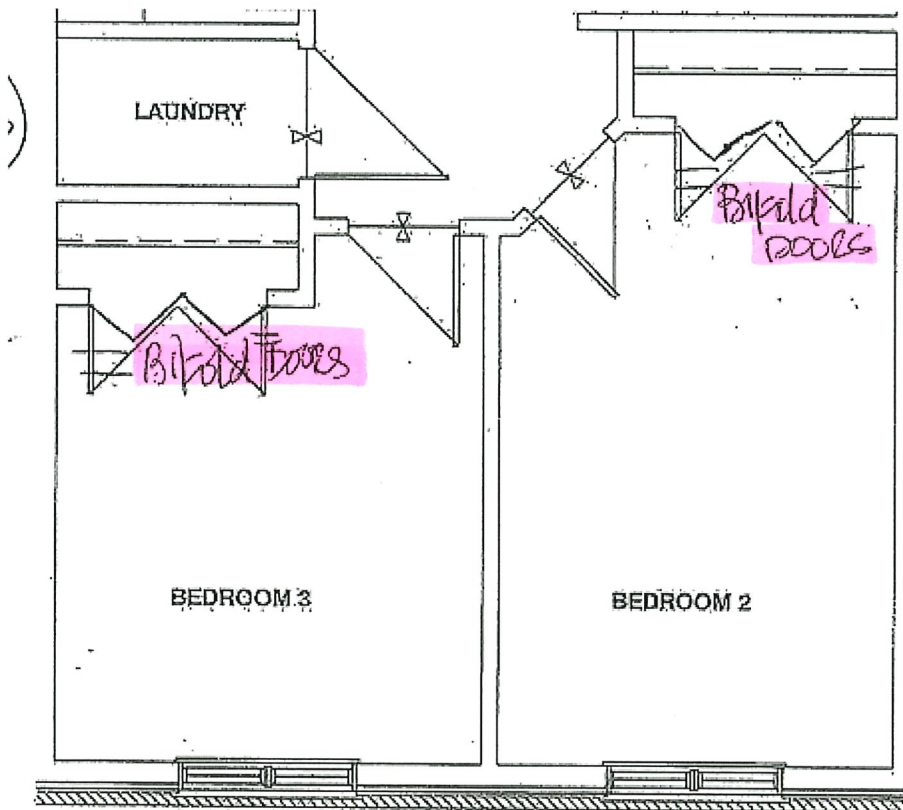

Good afternoon Ariel,

Taking item #12 as the reference point the replacement would be for two (2) sets of double bifold in lieu of double pre-hung doors (item #13, #14):

Credit for double doors: $\$486.00 \times 60\% = (-\$291.60) \times 2 = (-\$583.20)$
Double bifold (max opening 72"): $\$157 \times 2 = \$314.00 \times 2 = \$628.00$
Total: $(-\$583.20) + 628 = \44.80
