Based on the PO, we are to order a stainless microwave combo. However, upon cross-referencing the construction summary, Line 17 specifies that the standard microwave hood fan combo should be replaced with a basic white hood fan (270 CFM). It also references Line 18, which requires the ordering of a basic stainless hood fan. Please see the screenshots below for your reference:
