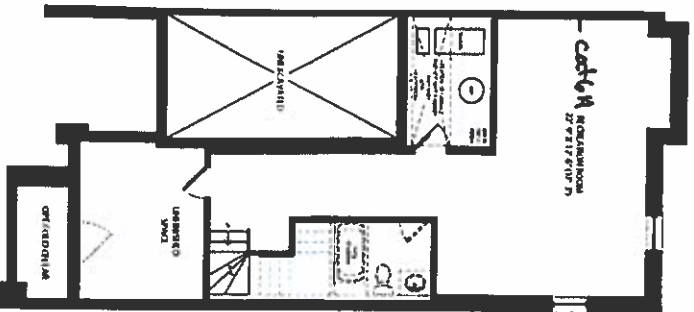

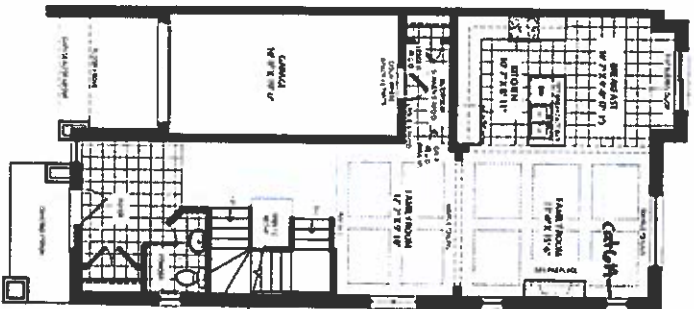

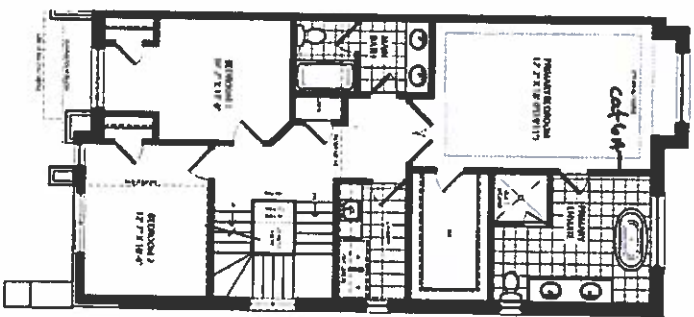

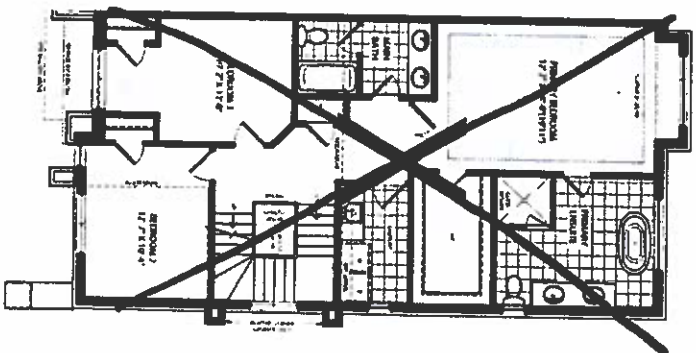
GROUND FLOOR ELEV B
END CONDITION



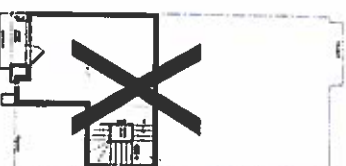
SECOND FLOOR ELEV B
END CONDITION



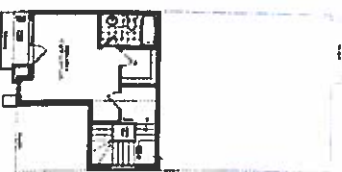
SECOND FLOOR ELEV B
